



REACHING HOME - CALL FOR PROPOSALS 2022/2023 – 2023/2024


INFORMATION FOR APPLICANTS

The Lakehead Social Planning Council is currently accepting funding applications from agencies aimed at preventing and reducing homelessness. Funding is provided by Canada's Homelessness Prevention Initiative, Reaching Home, Canada's Homelessness Strategy. Through Reaching Home, the federal government has reinforced its community-based approach, delivering funds for projects that aim to reduce and/or prevent homelessness, and to prevent the risk of homelessness. Projects must fully meet Reaching Home Directives. Reaching Home Directives can be found [here](#).

1. Projects for the 2022/2023 fiscal year are anticipated to begin April 1, 2022, and all projects will be funded for two fiscal years ending March 31, 2024.
2. Proposal submissions must have all supporting documents attached.
3. Proposal submissions that do not have supporting documents attached will not be assessed.
4. Handwritten applications will not be accepted.
5. The Lakehead Social Planning Council takes no responsibility for delays or losses by Canada Post or other courier companies. Proposals arriving after the deadline date and time will not be accepted.
6. If any sections or supporting material is missing or incomplete, the proposal will not be evaluated by the Proposal Review Committee.

A Maximum of **\$254,639** for fiscal year one is available (April 1, 2022 – March 31, 2023);

A Maximum of **\$254,000** for fiscal year two is available (April 1, 2023 – March 31, 2024).

DEADLINE FOR SUBMISSIONS

Deadline for Submissions is **Monday, January 31, 2022 at 5:00 pm Eastern Standard Time.**

Proposals submitted after this deadline will not be considered.
